**NOW THEREFORE BE IT RESOLVED** that the Board hereby establishes a Community Economic Development Program for all Proposition "A" work which includes the following elements:

**Community Business Enterprise Program** geared to encouraging consultants and contractors to utilize local, small, emerging and disabled-veteran-owned businesses neighboring each of the colleges on Proposition "A" work.

**Local Hire Program** geared to involve local residents living in the areas neighboring each of the colleges in both trade and non-trade job opportunities on Proposition "A" work.

**College Internship Program** geared to involve LACCD students at each of the colleges on Proposition "A" contracts.

**Special Opportunities Program** geared to involve those who are socio-economically disadvantaged and others in training and job opportunities on Proposition "A" projects.
